

The Terms and Conditions of the Competition on the EEA and Norway Grants Facebook profile

§ 1. The purpose of the Competition

The aim of the Competition is the promotion of the EEA and Norway Grants. The Competition will be conducted on November 10, 2020, on the EEA and Norway Grants Facebook profile, run by the Competition Organiser, where an announcement about the Competition will be published along with a link to these Terms and Conditions.

§ 2. The Competition Organizer

The Organizer of the Competition is the Ministry of Development Funds and Regional Policy, 2/4 Wspólna St., 00-926 Warsaw.

§ 3. The Founder of the prizes

The Founder of the prizes are the EEA and Norway Grants.

§ 4. The Participants of the Competition

Adult, legally capable natural persons who are 18 years old or older at the time of the Competition may participate. Employees of the Organizer are excluded from the Competition.

§ 5. The rules regulating the Competition

1. The person taking part in the Competition must correctly answer the question asked in the Competition post.
2. Answer to the competition question should be given in the comment below the post promoting the Competition.
3. First 15 people with the correct answer to the Competition question, published in the comments below the post promoting the Competition, will become the Winners of the Competition.
4. The following comments shall be deemed unacceptable, preventing the participant from winning prizes referred to in §7:
 - a) of an advertising nature or intended to conduct political or religious propaganda;
 - b) the content or publication of which violates the rights of other entities, including infringing their copyright or rights to protect their image;
 - c) that are contrary to Polish law, in particular calling for racial, ethnic and religious hatred, promoting violence and illegal substances;
 - d) commonly recognized as morally reprehensible, socially improper or in violation of the principles of social life;
 - e) containing profanity.

§ 6. Competition Jury

The Competition Jury consists of representatives of the Organizer.

§ 7. Prizes

1. Each of the 15 Winners will be awarded with a voucher in the form of a code (along with instructions for use) for a film screened online in the "Oslo/Reykjavik 3 Section" during the 20th New Horizons International Film Festival, organized by the New Horizons Association, with the support of the EEA and Norway Grants.
2. One voucher allows you to watch one of the films in the "Oslo/Reykjavik 3 Section" for free.
3. The code is active throughout the festival (until November 15, 23:59).

5. The prize or part thereof cannot be redeemed for cash.
6. The voucher allows you to watch the movie only from Poland.

§ 8. Information about the Winners

1. Winners will be notified via a Facebook message and will receive a voucher number to redeem in the same message. The Organizer is not responsible for the inability to transfer the prizes for reasons attributable to the Winner.
2. Should the Winner resign from the prize or the Winner loses the right to the prize, the Organizer reserves the right to designate another Competition Participant as the Winner.
3. By participating in the Competition you fully accept these general Terms and Conditions.
4. Facebook is fully released from liability by each Competition Participant.
5. The Competition is in no way sponsored, endorsed or conducted by the Facebook or associated with it.

§ 9. Personal data

1. The Minister of Finance, Development Funds and Regional Policy is administrator of your personal data processed in connection with the functioning of the website:

2. The principles of data processing by the Minister of Finance, Development Funds and Regional Policy are as follow:
 - 1) The seat of the Minister of Finance, Development Funds and Regional Policy is located in Warsaw, at 2/4 Wspólna St, postal code 00-926.
 - 2) You can contact the Data Protection Officer at the Ministry of Development Funds and Regional Policy using the following address: IOD@mfi.gov.pl. Should you consider that your personal data is

being processed in a way that violates the law you can file a complaint to the supervisory authority in Poland (the President of the Office for Personal Data Protection).

3) Your personal data is processed on the basis of Article 6, § 1, letter e) of GDPR, to conduct a promoting Competition and expanding knowledge about the EEA and Norway Grants, and in particular:

a) to ship a prize, in case of winning the Competition;

b) to answer questions sent by means of a message on Facebook in the Participant's legitimate interest consisting in obtaining the given information;

c) to announce the Winners of the Competition by sending them a message on Facebook with the information about the prize.

4) The access to personal data is obtained by authorized employees of the Administrator in connection with the performance of official duties and entities providing services to the Minister in the field of provision and maintenance of ICT infrastructure.

5) The provision of your personal data is voluntary.

6) Your personal data will be stored for a period of at least five years from the date of acceptance by the institutions representing the Donor States of the EEA and Norway Grants of the final report for the programme this Competition is funded from, and then, to the extent necessary, for the period specified in the provisions on archiving.

7) At any time the Participant may exercise the right of access to data, rectify data, delete data, limit processing and object to data processing to the extent and on the principles set out in the GDPR. 8) Your data will not be used for automated decision making.

The Organizer reserves the right to cancel or discontinue the Competition. Such a decision will be announced on the EEA and Norway Grants Facebook profile.
